Mayor Kennedy opened the regular meeting of the Belvidere Town Council with the Pledge of Allegiance and Teresa Yeisley read the following notice in compliance with the Open Public Meetings Act:

Councilwoman Napolitani, Councilwoman Miers and Mayor Kennedy presented the following proclamations:

Whereas,	in the United States, an estimated 60,000 new cases will be diagnosed this year alone; and
Whereas,	there is no objective test for Parkinson's disease and the rate of mis-diagnosis can be high; and
Whereas,	there is no cure, therapy, or drug to slow or halt the progression of Parkinson's disease; and
Whereas,	increased education and research are needed to help find more effective treatments with fewer side effects and, ultimately, an effective treatment or cure for

Committee Reports:

Councilman Makatura - 327 calls for service in February; signs for municipal parking areas will be installed and the PD will issue warnings for one week; Chief Scott selected a candidate for the Court Attendant position; will meet with Chief and Principal regarding a Drug Awareness Program; court window installed and passed inspection with the AOC.

A motion was made by Councilman Makatura and seconded by Councilwoman Miers authorizing Chief Scott to proceed with the three-year lease/purchase of a 2016 Ford Explorer at a cost of \$37,984.

A motion was made by Councilman Makatura, seconded by Councilwoman Napolitani and carried to authorize the hiring of George Duckworth as Court Attendant at \$75 per court session.

Councilwoman Napolitani - DPW doing tree and brush trimming. Brush pick-up for the Town has been scheduled for the beginning of April. Councilman Fitzgerald asked who authorized that the yellow curbs in the up-town business area be painted grey, adding that this should have been a Council decision. Mayor Kennedy responded that he asked John Snyder to paint the curbs to afford more parking.

Councilman Miller - the Historical Commission has chosen three sites for their fund raiser (the Warren County Court House, the Episcopal Church and possibly the Shoe Tree); attended a meeting regrading the sale of the BASF property.

Councilwoman Miers - BOE passed their preliminary budget with a \$72,000 increase and public hearing on April 27th. Recreation Committee meeting to discuss potential activities.

Councilman Fitzgerald - no report at this time.

Councilman Tutka - Pool Commission reviewed their budget and discussed personnel. Met with Fire Chief to discuss alley access and fire truck. Met with Belvidere Ambulance Corps members and discussed outside service. Toured DPW facility with a contractor who recommended that the structure come down.

Teresa Yeisley - FEMA declaration for January winter storm Jonas. Town will receive reimbursement for salt and OT.

Previous Business:

Discussion of 2016 budget and update on progress.

Meeting scheduled for Councilwoman Napolitani, Paul Sterbenz, John Snyder and Teresa Yeisley to discuss Oxford Street Phase III, DPW garage project and the generator project.

Library referendum - Kevin Benbrook provided Council with a proposed ordinance for a referendum to dissolve the Belvidere Free Public Library and advised Council on the process involved.

The following are comments regarding the proposed ordinance:

Councilman Miller - referendum question is needed due to the financial repercussions.

Mayor Kennedy - may need town hall meeting with library.

Nancy Brown - ownership of building.

Marcia Haag - referendum question and bequeathed funds.

Eileen Scott - binding referendum

Heather Stokes - added tax.

Harry Brown - accurate numbers and facts needed from County. Need to consider employees rights and liabilities.

Councilwoman Napolitani - spoke with County Administrator regarding negotiation with employees.

Councilwoman Miers - email Council with questions.

Heather Durr - referendum question.

PJ Serrano - need apples for apples information. Use of volunteers at library.

Kevin Benbrook - Library Board of Trustees is a quasi-independent entity.

A motion was made by Councilwoman Miers and seconded by Councilman Makatura to introduce Ordinance No. O2016x03.

ORDINANCE NO. O2016x03

TOWN OF BELVIDERE

WARREN COUNTY, NEW JERSEY

AN ORDINANCE TO PLACE A REFERENDUM QUESTION ON THE NOVEMBER BALLOT TO DISSOLVE THE TOWN'S FREE PUBLIC LIBRARY AND JOIN THE COUNTY LIBRARY SYSTEM

WHEREAS, the Town of Belvidere maintains a free public library and assesses a property tax levy upon the residents to provide the funds for the operational costs of the library; and

WHEREAS, the operational costs of the library are increasing, its hours of operation pursuant to which it is open to the public are limited, and its financial reserves depleted such that the ability to meet the library's future operational budgets without increasing the property tax burden upon the residents is in doubt; and

WHEREAS, the County of Warren maintains a County library system and has recently completed and opened a new, modern public library facility within a few miles of the Town of Belvidere, making the same convenient and accessible for the residents of the Town; and

WHEREAS, the Mayor and Town Council of the Town of Belvidere in the County of Warren is of the opinion that the public interest will best be served by dissolving the Town's library and joining the County library system and wish to place the dissolution of the Town's library as a binding referendum question for the vote by the residents of the Town.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Belvidere, County of Warren, State of New Jersey, as follows:

- I. Pursuant to the provisions of <u>N.J.S.A.</u> 40:54-7.1, a question shall be placed on the ballot of the next general election seeking a vote by the legal voters of the Town whether they approve or disapprove of the dissolution of the Town's public library.
- II. Pursuant to the foregoing statute, the question to be placed on the ballot shall be in the following form:

"Shall the free public library established pursuant to R.S. 40:54-1 et seq. in the Town of
Belvidere be dissolved effective December 31, 2016 and provision made for assessing, levying, and
collecting the special tax assessed, levied and collected to support the County library system entitling
the residents of the Town of Belvidere to receive the same County library assistance services as are
received by other municipalities within the County library system?"

III. In accordance with the statute, the following interpretive statement shall be included on the ballot:

"If the voters approve this question, the Town's free public library will be dissolved, and the Town will become part of the Warren County library system."

- IV. Upon adoption, a copy of this ordinance shall be filed with the Director of the Division of Local Government Services in the Department of Community Affairs and with the State Librarian.
- V. If the dissolution of the Town's library is approved by a majority of the voters, pursuant to statute, the Town shall assume the assets and liabilities of the library, effective upon the date of dissolution. The Mayor and Town Council shall hold a joint meeting with the library board of trustees and the County library governing body as soon as practical for the purpose of implementing discontinuance of the use of the library facilities, the adjustment, the apportionment and accounting of all of the rights and liabilities and property of the Town library and arriving at an agreement with respect thereto. Pursuant to statute, in the absence of a mutually acceptable agreement, the Director of the Division of Local Government Services shall resolve the same.
- 3. This ordinance shall become effective after final passage and publication according to law and filing with the County of Warren as may be applicable.

NOTICE

The foregoing ordinance was introduce at a meeting of the Belvidere Town Council held on March 21, 2016 and was read for the first time. This ordinance will be further considered for final adoption by the Belvidere Town Council at a meeting to be held on May 16, 2016 at Belvidere Town Hall, 691 Water Street, Belvidere, NJ at 7:00 P.M. or at any time and place to which said meeting may be adjourned. All interested persons will be given the opportunity to be heard concerning said ordinance at that time. Any member of the general public can obtain a copy of said ordinance at no cost at the Municipal Clerk's Office, 691 Water Street, Belvidere, Monday through Friday from 9:00 A.M. to 4:30 P.M.
