# MINUTES - TOWN COUNCIL MEETING TOWN OF BELVIDERE WARREN COUNTY, NEW JERSEY

Mayor Stettler opened the regular meeting of the Belvidere Town Council with the Pledge of Allegiance and read the following notice in compliance with the Open Public Meetings Act: In accordance with Chapter 231 of the Public Laws of 1975, notice of this meeting was given by way of notice filed with the Star Gazette and/or the Express-Times, filed in the Municipal Clerk's Office and posted in the Belvidere Town Hall, 691 Water Street, Belvidere NJ.

# **Approval of Minutes:**

**A motion** was made by Councilman Sebold, seconded by Councilwoman Miers and carried to adopt the November 3, 2014 regular and executive meeting minutes of the Belvidere Town Council.

#### Oath of Office:

Matthew Scott was sworn in as Chief of Police by Teresa Yeisley.

#### **Public Comment:**

Rheva Smickle asked when Bob Yeisley would be receiving recognition by the Council for his years of service.

#### **Committee Reports:**

Councilman Makatura - no report at this time.

Councilwoman Napolitani - gave DPW year-end report and submitted DPW and Sewer budgets. The wrap-up of the nutrition center ad-hoc committee is scheduled for December 4<sup>th</sup>.

Councilman Sebold - submitted PD budget.

**A motion** was made by Councilman Sebold, seconded by Councilwoman Miers and carried to advertise for a full-time police officer.

**A motion** was made by Councilman Kennedy, seconded by Councilwoman Napolitani and carried to advertise for substitute crossing guards.

Councilwoman Miers - reminded all liaisons to make sure that their departments are mindful of their spending. Attended a Sewer Committee meeting where they discussed alternatives for sewer billing.

**A motion** was made by Councilwoman Miers, seconded by Councilman Kennedy and carried requesting a more detailed zoning report and a year-end zoning report.

Councilman Kennedy - provided year-end recreation report. Thanked Chief Yeisley for soliciting donations for lighting the Christmas wreaths. Lights on buildings in downtown area donated by Victoria Meghdir with remaining funds from previous Town events. Thanked DPW for their work at the tennis courts. Attended NJSLOM Conference and sought information on mayoral term.

Councilman Makatura - provided year-end reports on Environmental, Historic and Planning.

Mayor Stettler - receiving good response to emergency preparedness presentation. Attended NJSLOM Conference and was asked to be on the nominating and legislative committees. Also did an interview with Comcast.

Councilwoman Miers initiated a discussion about the possibility of another municipality sharing our court. Mayor Stettler reported that she will be scheduling a meeting with John Inscho, Mayor of Liberty Township to discuss this matter.

Councilwoman Miers reported that she researched the deeds for the "Bear Town" Cemetery and found that the cemetery is still owned by the Methodist Church.
